We invite you to be a participant in the show as a vendor, which in 2019 attracted close to 1,000 paid attendees, as well as our volunteers and members.

10' x 20' space with 2 x 8 ft. table and 4 chairs\$395.00

Pipe and drape and electricity will be provided for each booth.

Merchant Contract:

- Sinnissippi Quilters Inc. and Mercy Health Sportscore Two will not be responsible for personal injury, loss of money or property while you are participating in the show.
- Should the show be cancelled for any reason (e.g. fire, flood, tornado) you waive claims for damages; however, your booth rental payment will be refunded.
- Certain areas may not be blocked due to fire and safety regulations. Items extending beyond booth boundaries will be removed.
- Set-up time is between 11:30am and 6pm on Friday, April 29, 2022. We will have volunteers to help sole vendors unload. You are encouraged to bring your own cart/s as the facility has very few available.
- Directions where to unload your merchandise will be explained in a follow-up letter as we get closer to the date of the Show. Vendors and show volunteers are being asked to park away from the building during the show times saving the front lot for the attendees.
- The doors will open at 8:00am on Saturday morning and 9:00am on Sunday.
- Teardown will begin **no earlier** than 4pm on Sunday and must be completed by 6pm. We will not have volunteers available to help at this time.
- Return this contract with full payment as soon as possible. Vendor spaces will be filled on a first come first served basis. Your check will be returned if there are no spaces available. Rental fee is non-refundable unless space can be re-assigned.

Would you like to sponsor an "Achievement in Excellence" Award? Select an achievement, for example best machine quilting, best use of color etc. Your prize may be awarded to any quilt in the show, not just those submitted for judging; this will give all entrants an equal opportunity. Awards will be presented on Saturday afternoon and there will be a placard to indicate your award. Award categories and sponsors will be listed in the show booklet.
